

Dice Dreams Sweepstakes

Official Rules

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. A PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING. VOID IN WASHINGTON STATE, AND WHERE PROHIBITED.

- 1. OVERVIEW:** The Dice Dreams Sweepstakes (“Sweepstakes”) consists of five (5) separate Daily Drawings (as defined under Rule 5 herein). You may only enter into each Daily Drawing one (1) time. Entry into each Daily Drawing is separate. Entry into one Daily Drawing is not entry into any other Daily Drawing.
- 2. ELIGIBILITY:** The Sweepstakes is open only to legal residents of the fifty (50) United States (excluding Washington State), and D.C., who are 21 years of age or older. Employees and their immediate family members of SUPERPLAY Ltd. (“Sponsor”), American Broadcasting Companies, Inc., as well as persons involved in the creation, development or production (including cast and crew) of The View television show, Brandmovers, Inc., d/b/a The A Team (“Administrator”), and each of their respective employees, representatives, franchisees, parents, retailers, distributors, subsidiaries, affiliates, suppliers, advertising agencies, and persons living in the same household as such employees are not eligible to participate in the Sweepstakes. The Sweepstakes is subject to all applicable federal, state, and local laws and regulations and is void where prohibited by law. Sponsor reserves the right to verify the eligibility and all facts at any time, and all Sweepstakes entrants (“Entrants”) agree to cooperate in any verification process/request.
- 3. SWEEPSTAKES PERIOD:** The Sweepstakes begins on October 21, 2024, at 12:00:01 AM Eastern Time (“ET”) and ends on October 25, 2024, at 11:59:59 PM ET (“Sweepstakes Period”); however, each Daily Drawing has its own separate entry period as described in Rule 5 below. The Administrator’s database clock is the official timekeeper for this Sweepstakes. See entry periods for Daily Drawings in Rule 5 below.
- 4. HOW TO ENTER:**
 - (a) Electronic Entry: During the Sweepstakes Period, log into your free Dice Dreams account (“Account”) via the free Dice Dreams mobile game app (the “App”) which is available for free download via the App Store or Google Play on any iOS or Android mobile device. Once you are logged into your Account, (a) follow the prompts to connect your Account to Facebook, (b) click on the ‘INVITE’ button to invite one (1) or more friends using either email, SMS or direct message (e.g., Facebook Messenger) (not open to residents of Washington State) to join Dice Dreams. Once the friend clicks on the link you provided, downloads the App ***and*** connects to their Facebook account, you will receive one (1) entry into the Daily Drawing for the day on which your friend has completed ***all*** the above steps. You do not earn an entry until ***all*** the steps are completed. Any entry is only for the day on which your friend completes the final step. Completion of that step after the end of the Sweepstakes Period will not result in any entry for any Daily Drawing. If you do not already have an Account, follow the instructions in the App to create your Account. You must log into the App using your free

Account to be able to obtain an entry as described above. Limit of twenty (20) entries per person/Account per Daily Drawing (see chart in Rule 5 below), regardless of method of entry.

- (b) **Mail-In Entry:** To enter for free and without downloading the App or needing to have friends follow the steps described in Rule 4(a) above, neatly handprint on a piece of paper your name, complete address (with ZIP code), age, and email address. Then, mail your completed entry in a stamped first-class hand addressed envelope to: Dice Dreams Sweepstakes, PO Box 1468, Social Circle, GA 30025. Please indicate the day (number 1, 2,3, 4 or 5) you are entering, and the number of entries you are requesting for that day (up to a maximum of twenty (20) per request. Incomplete, illegible, damaged, incorrectly addressed, late, lost, misdirected and postage-due entries will not be accepted, acknowledged, or returned. You may submit multiple postal requests, including multiple requests for any individual Daily Drawing; provided that each such request (a) must be mailed separately, (b) must be postmarked during the Sweepstakes Period and on or before the applicable entry period day per the chart in Rule 5 below, (c) must be received by the applicable deadline for that Daily Drawing per the chart in Rule 5 below, and (d) can seek a maximum of twenty (20) entries for the applicable Daily Drawing. Limit of 20 entries per person/Account per Daily Drawing, regardless of method of entry.

Any attempt to enter more than twenty (20) per Daily Drawing during the Sweepstakes Period by any means, including, but not limited to, use of multiple identities, email addresses, Accounts, or other means, may result in disqualification from this and any other promotional offerings by Sponsor. Use of any macro, bot, script or other automated means to submit entries is prohibited. In the event of a dispute over the identity of the Entrant in connection with an electronic entry, the entry will be deemed submitted by the authorized account holder of the e-mail address associated with the Account associated with the entry. "Authorized account holder" is defined as the natural person who is assigned to an e-mail address by an Internet access provider, on-line service provider, or other organization (e.g., business, educational institution, etc.) that is responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address.

5. **RANDOM DRAWINGS AND WINNER NOTIFICATIONS:** A series of five (5) daily drawings ("Daily Drawings") will be held, one (1) relating to each day during the Sweepstakes Period per the chart below. The drawing for each day will be held from among all eligible electronic entries received during the relevant daily entry period per the chart below, along with all eligible postal entries identifying that same Daily Drawing per Rule 4(b) above and received per the chart below. Entry into each Daily Drawing is separate. Entry into one Daily Drawing is not entry into any other Daily Drawing. Each daily entry period begins at 12:00:01 a.m. ET and ends at 11:59:59 p.m. ET on the applicable "Entry Period Day" stated in the chart below.

For clarity, and subject to Rule 4(b), a mail-in entry is eligible for any Daily Drawing Number it identifies to be entered into as long as the entry is (a) postmarked during the Sweepstakes Period and no later than the “Entry Period Day” for such Daily Drawing and (b) received by the applicable “Mail-In Entry Received By” date for such Daily Drawing, in each case per the chart above.

Each Daily Drawing will occur within approximately 48 hours (or the next business day thereafter) after the mail-in entry deadline for the applicable entry period per the chart above, and will be conducted by the Administrator to select five (5) potential winners from all eligible entries received for that Daily Drawing. Entrants irrevocably agree to be bound by these Official Rules and by the decisions of the judges, which are final and binding in all respects.

Each potential winner will be notified after the relevant drawing using the email address associated with their Account or such other contact information supplied via a mail-in entry request when applicable. No liability is assumed for any winner notification that is lost, intercepted or not received by a potential winner for any reason. Failure to respond to any winner notification within five (5) days may result in disqualification and selection of an alternate winner. Failure to comply when requested may result in disqualification and selection of an alternate winner. If a potential winner is found to be ineligible, or if he or she has not complied with these Official Rules or declines a prize for any reason prior to award, such potential winner will be disqualified and an alternate winner may be selected.
