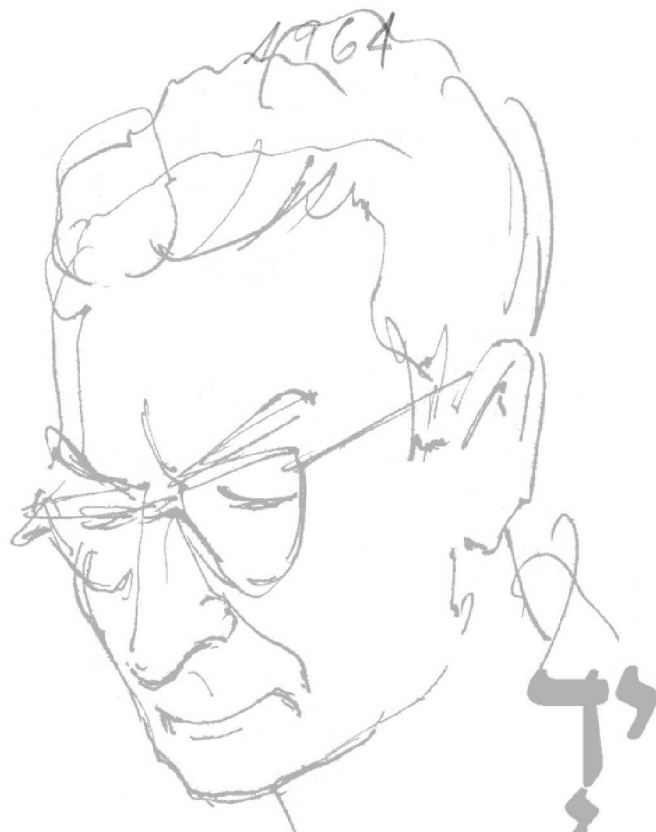

JERUSALEM

20 MAY 1964

WE APPEAL TO GOVERNMENT SOUTH AFRICA TO STOP CURRENT PRETORIA TRIAL OF ARRESTED OF RIVONIA, OF NELSON MANDELLA AND OTHERS, LEADERS OF POPULAR STRUGGLE AGAINST RACIAL RULE. ALL MEN OF GOODWILL SHARE THEIR ABHORRENCE OF IDEA OF EXCLUSIVE WHITE SUPREMACY AND ^{Support} THEIR SIMPLE DESIRE TO LIVE AS FREE MEN.

WE APPEAL TO YOU :SHED NOT BLOOD OF MEN AND WOMEN WHO SEEK ONLY TO HOLD UP THEIR HEADS IN DIGNITY . THOSE WHO YOU HAVE PLACED IN DOCK ARE AS CREATED EQUAL WITH YOU -YOUR BROTHERS. TALK TO THEM, LISTEN TO THEM. THEY HAVE SOMETHING TO SAY. YOU WILL NOT SILENCE THEIR VOICES BY HANGING THEM. THEIR WORDS WILL RING A THOUSAND TIMES MORE LOUDLY IF YOU DO. A HARSH JUDGEMENT WILL NOT SOLVE YOUR PROBLEM, NOR WILL IT DIMINISH RIGHTEOUSNESS OF THEIR PLEA FOR FREEDOM.

YOURS IS SUPREME OPPORTUNITY OF PROCLAIMING SUPREMACY OF SANITY AND UNDERSTANDING OVER RUTHLESSNESS. YOU HAVE POWER TO IMPRISON, TO KILL. SUSPEND IT. FREE THE ACCUSED. SIT DOWN WITH THEM. NEGOTIATE WITH THEM. GIVE EAR TO THEIR PLEA FOR SELF-DETERMINATION.

FROM LAND OF ISRAEL , WE ASK YOU TO ASSERT YOUR FAITH IN NOBILITY OF MAN, WHATEVER COLOUR OF HIS SKIN. AND IF YOU "DO UNTO OTHERS" IN ACCORDANCE WITH THIS FAITH, THE FUTURE IS YOURS , THEIRS-AND THE WORLD'S.

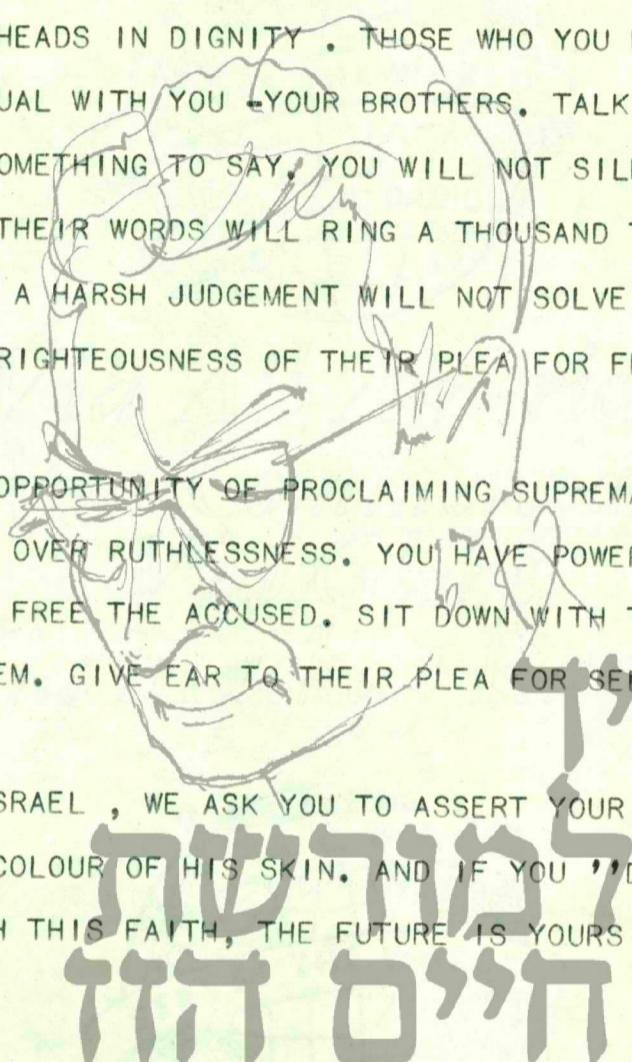
